We are a charmingly-renovated, historic warehouse on a unique block in the Kansas City Crossroads Arts District. Our three-story, 30,000 square-foot building features galleries, artists' studios,arts-inspired retail and services and small businesses. In addition, we have a one-of-a-kind event space with a spectacular view of the Kansas City skyline and plenty of unique and personal touches: exposed brick, Italian-bulb string lights, warehouse windows, an original freight-elevator, handmade furniture and one-of-a-kind architectural details. The Kauffman Center for the Performing Arts glimmers through our windows just one block north; and local galleries, restaurants and shops are peppered throughout our neighborhood. We look forward to working with you in making your shoot a memorable and professional experience.

BUILDING

____ In addition to three floors of renovated warehouse space filled with natural lighting, there are numerous areas of unique character (e.g., freight elevator, wood shop, commercial kitchen, original artwork, etc.). The main event space is 2920 sq. ft. with 10.5' - 11' tall ceilings and floor-to ceiling windows on the North, East and West walls. There is also a 1000 sq. ft. auxiliary "Parlour" with full warehouse windows on the South and West walls, as well as a professionally-decorated Bride's Room/Green Room and Groom's Room/Green Room.

RATES

- _____ Single photographer with minimal equipment and 1-3 clients: \$50/hr
- ____ Small photo/video crew (3-6) with props, make-up, lighting, etc.: \$100/hr (\$200 min.)*
- ___ Large photo/video crew (7-20) with props, make-up, lighting, etc.: \$125/hr (\$250 min.)*

____ Use of commercial catering kitchen during shoot: an additional \$250/day

*General liability insurance is required for Small & Large photo/video crews. Certificate must be submitted 2 days prior to the shoot.

ACCESS

____ Space is available for shoots Monday through Thursday & weekends that are not booked for events. Weekend shoots cannot be scheduled more than 30 days in advance to avoid conflict with events. Although your shoot will remain uninterrupted, please be aware that The Bauer has numerous studio tenants/staff who have access to the building at all times.

FURNITURE

You can rent Bauer furniture or you're welcome to bring in your own. Prices are as follows:
Tables: \$8/each (66" round plastic tables, 6' and 8' banquet tables and cocktail tables)
Garden Chairs: \$2.50/each (white, wooden, padded folding chair)
Standard Chairs: \$1.25/each (white, metal, plastic folding chair)
Handmade, artisan bars: \$25/each (6', bar height)

PARKING

____ There is private lot-parking available after normal business hours, as well as over 170 three-hour street parking spots in a two-block radius during daytime hours.

STAFF

___ We will provide a staff member to be present during your shoot if you fall into the large photo/video crew category. The staff member will supervise your event and provide elevator assistance, if needed.

CONTRACT
